The process of developing a new strategic plan began in July 2021 with the development of a Stakeholder Planning committee. A Visioning Task Force, made up of various district stakeholders, met over four days in October and December 2021 to identify areas of opportunity for the district. These findings were used to develop seven new Strategic Goals and four Strategic Priorities that will drive the work of the district over the next three years.

A 30-member Citizens' Bond Committee met multiple times to review and discuss potential bond projects. The Committee consisted of parents, students, community members, district staff, senior citizens, and business/community leaders. Together, this group presented proposals to a citizen's Steering Committee who then refined the work into one proposal submitted to SISD Trustees. After careful review and deliberation, Trustees voted to approve a bond proposal in the amount of \$7.5 million.


PROPOSITION A - BASEBALL & SOFTBALL COMPLEX




ONE FACILITY ON CAMPUS

Seguin ISD students do not currently have access to an on-site, competitive baseball field, just as other districts do. Currently, players and coaches must travel across town to the City's baseball field for home games.

Matador Baseball plays home games at Smokey Joe Field owned by the City of Seguin near the fairgrounds. A new baseball field on the Seguin High School campus would eliminate the need for players and coaches to travel across town to the City's field. By pairing a new baseball field with a new softball field at Seguin High School, both sports could share common facilities at the complex, such as the ticket booth, restrooms and concession.



The new Matador Baseball and Softball Complex would be on campus and accessible to all high school student athletes without having to travel to other fields for practice or home games.















CURRENT CONDITIONS

Seguin ISD maintains Seguin Parks & Recreation Smokey Joe Field at the Seguin Events Complex for games & practices. In 2019, SISD invested \$300,000 in grading & reseeding the fields to get them competition ready. The cost of fertilizer, pesticides, & weed control is approximately \$20,000 annually. This does not include the cost to grade & stripe as well as the labor. Flooded fields result in missed class time, missed practice time, & lack of home field advantage in UIL competitions.

Prompting these designs were the current conditions of both playing fields. The New Baseball and Softball Complex would include
