# **Frequently Asked Questions**

#### What is a Tax Ratification Election (TRE)?

Texas law requires school districts to calculate two tax rates--the Maintenance and Operation (M&O) tax rate and the Interest and Sinking (I&S) tax rate--after the district receives the certified appraisal rolls or certified property value estimates from the certified appraiser. The state limits the M&O rate at \$1.04. Generally, if a school board adopts a tax rate above the \$1.04 rollback rate, it must hold a TRE to ratify that rate. If a majority of the

votes cast in the TRE favor the proposition, the tax rate for the current year becomes the rate adopted by the board. If the TRE is not approved, then the board may not adopt a tax rate for the current year that exceeds the rollback rate.

There are two types of TREs. With a straight TRE, the M&O tax rate is increased through an election. With a penny swap TRE, the M&O tax rate is also increased through an election; however, the I&S rate is lowered, limiting the total increase in the tax rate.

# Why is Seguin ISD proposing a TRE and how will it affect the tax rate?

The Seguin ISD Board and administration are seeking ways to increase efficiency with tax revenues and fund the needs of the District by limiting the tax burden as much as possible. One way to do this is through a TRE.

During the 2015-16 school year, Seguin ISD's I&S tax rate was 37 cents and

the M&O tax rate was \$1.04 for a total tax rate of \$1.41. For the 2016-17 school year the District is scheduled to increase the I&S tax rate to 39 cents.

If Seguin ISD voters approve the TRE, scheduled for Sept. 10, 2016, the M&O tax rate will be set at \$1.06. Additionally, the School Board has committed to lowering the I&S tax rate 3 pennies from what the I&S tax rate must be for 2016-17, from 39 cents to 36 cents. If the TRE is passed, the total tax rate will be \$1.42.


If approved, each penny will generate approximately \$700,000.00 in state revenue for the District. This is because the M&O rate has a greater weight in state funding

formulas compared to the I&S rate. The increase of about \$1.4 million will be use to fund a 4 percent pay raise for teachers and a \$1 an hour pay raise for bus drivers, paraprofessionals, custodians, maintenance and food service employees.

If the TRE does not pass the total tax rate will be \$1.43, an increase of 2 cents from the prior year. Additionally, funds will not be available to provide teachers a 4 percent pay raise or a \$1 an hour pay raise for bus

drivers, paraprofessionals, custodians, maintenance and food service employees.

The voter's choice in this TRE is between an overall increase of 1 cent as opposed to an overall increase of 2 cents. The tax bills for individuals over 65 or Disabled homesteads are frozen and will never increase unless significant improvements are made on the home. The District is choosing to call a TRE as opposed to raising the I&S tax rate by 2 pennies, which would not have required an election, based on two reasons. First, due to the way Texas public school funding is formulated, pennies generate more funds from the State if they are in the M&O fund as opposed to the I&S fund. The second reason is to give taxpayers a choice on their tax burden. If approved by voters, the overall increase in taxpayer's tax burden is lower and a greater amount of funds from the State will be sent to Seguin ISD.



# Why is the TRE being held in September and not November?

The Board of Trustees adopted the M&O tax rate that triggered the TRE on June 21, 2016. State law requires the District to hold the election 30 to 90 days after that date.

# Have other districts approved TREs?

Yes. Hundreds of communities across Texas have voted to approve a TRE. Since 2006, 440 TREs have been approved statewide.
