A Regular Meeting of the Board of Trustees of Seguin ISD was held December 12, 2017, beginning at 6:30 p.m. in the Board Room, 1221 E. Kingsbury, Seguin, Texas.

C. Superintendent Announcements

Dr. Gutierrez provided an update on recent events and initiatives including the 90 Day Plan, Strategic Plan and holiday fine arts events.

D. Board Member Reports

Mr. John Holt attended Matador Band Banquet (\$14K raised), opening night of AJB Elf, Jr., two cheer competitions (San Marcos and Frisco), KWED Toy Drive

Mrs. Barbara Effenberger toured Matador Stadium, State of the District presentation, MBLC graduation ceremony, choir concert at Weinert ES

Mrs. Cinde Thomas-Jimenez attended the Band fundraiser, State of the District presentation, Art and Science Night at AJB, opening of Elf, Jr. at AJB, Weinert classroom for Week of Code, Mariachi concert, Choir concert, KWED Toy Drive and Strategic Planning workshop

B. Fund Balance (LOCAL) Policy Study of Area Districts

Mrs. Reihl prefaced by saying that the policy is general and would like to see more parameters for fund balance. Tony Hillberg, assistant superintendent of business services, conducted a study of multiple Texas school districts that have a local policy pertaining to a fund balance requirement. Nineteen districts were studied, 12 did not have a policy or one that addresses a fund balance requirement, while seven have policy that addresses a fund balance requirement. A daily cost of operations was calculated to compare Seguin ISD with the 7 districts. In all instances, Seguin ISD's fund balance was comparable. Dr. Gutierrez recommending revisiting the item in January with a 90 day or three month policy recommendation.

Consideration and Approval of School Health Advisory Council (SHAC) Annual Report, SHAC Goals and Committee Members—approved unanimously Pete Silvius, outdoor/physical education coordinator, along with SHAC community representatives Julie Steele and Lisa Burns, presented information on the SHAC as part of a required annual update.
- D. Personnel Action Professional Employees—approved unanimously Dot Whitman, assistant superintendent of administrative services, provided information on two new hires and two resignations.
