Minutes, September 14th, 2022

- Welcome and Introductions
 - (Chair Mark Dibble was not able to attend) Pete Silvius called the meeting to order 5:35.

- Update on on-going projects-
 - Michele and Edith motioned for approval of the May meeting minutes. Meeting minutes were approved as written.
- Member Business-
 - Pete shared a copy of the SHAC bylaws and membership roster. Pete explained that the SHAC has been providing the School Board with annual reports that included a list interested community members for possible SHAC appointment in January for the past 3 years. Pete shared that this schedule came as a result of the Covid shutdown and it might be better to go back to a school calendar report in early fall or late summer.

 - Pete shared a report of the community survey results. Participation was strong with 189 responses. The majority of the responses 48% were neutral to the question of-Should coffee be made available at the HS? 30% responded that it was a good idea and 21 responded that it was a bad idea. Sarah, Carmen and Edith will meet to sort free-response comments. The SHAC would like to acknowledge the concerns/comments shared within the survey.
 - Pete shared that the Seguin ISD School Board had issued a Resolution to charge the SHAC to provide a recommendation for an Injury Prevention Curriculum and a Sexual Health Curriculum for possible adoption. Allison Willemin will provide guidance to this process through her experience with instructional material adoption all other subject areas for Seguin ISD.
 - Michele Meehan shared information about RadKIDS and Child Safe Matters and Teen Safe Matters. RadKIDS is a program that Seguin ISD has been using to address child injury and abuse prevention in partnership with Guadalupe County Child Advocacy Center. Child Safe Matters and Teen Safe Matters are new programs that could also be considered for adoption.
